- 2. Ensure that offered plot has following criteria but not limited to:
  - a) Approach road should be minimum 12 meters.
  - b) The Plot should be with clear & undisputed title for setting up CNG Station.
  - c) No public place within 100 mtrs. radius like school/college/big temple/hospital etc.
  - d) No HT line should be passing through the plot

- 3. Availability of suitable sites for setting up of CNG stations at the advertised locations is the essence of the project. Accordingly, applicants who "Owns" or have registered long lease for a minimum period of 15 or more years with provision of sublease clause would be given weightage over applicants who have only a "Firm Offer" from third parties for obtaining suitable land either on ownership or lease basis
- 4. Application will be accepted only for the mentioned locations as per annexure.
- 5. The offered land if falls near to any existing / planned CNG stations may be considered based on CNG demand in that vicinity and without affecting sale of CNG of such existing /planned CNG station.
- 6. Investment required by the landowner will include the following major components under DODO policy-
  - **Dealer Owned Dealer Operated (DODO-type2-S):** Initial capital investment (excluding cost of land and security deposit) for charges towards civil, electrical, telephonic, water connections etc. and working capital for operating the CNG station towards provision and upkeep of basic facilities are as detailed in the Information Brochure.
